- (1) Mahesh, Ramesh and Suresh decided to commit robbery and with the express intention to commit crime he entered into Himalayan Gold Mall, with deadly weapons and ammunition. The shop owner-Gopal shouted for help and some locals came to his rescue. Among the locals who assembled, there was one Endrew who had an unlicensed gun. The gunda shot Mahesh and he died on the spot. By seeing this Ramesh and Suresh started running without committing robbery. Will Ramesh and Suresh be punished ? What will happen with Endrew ?
- (2) Three accused persons A, B and C was charged for kidnapping a child. The child was recovered from the custody of another person D. The other person D from whom the child was recovered had knowledge that the child was a kidnapped child. Discuss the penal provisions. Will D be punished under Penal Provisions ?
- (3) A says about a witness Z I do not believe that Z asserted at the trial because I know him to be a man without veracity. Is A's opinion defamation of Z ? Give reasons and also refer to the relevant provisions, if any, on the point under IPC.
- (4) A, a Magistrate in making a report to his own superior officer, casts an imputation on the character of Z for public good. Has A done any offence under IPC.

- (1) Section 508 penalizes words, gestures or acts intended to insult the modesty of a woman.
- (2) Section 494 is not applicable to Muslim males.
- (3) U/s 228A of IPC states that "No person can disclose the name of the rape victim and if anybody discloses the name, he shall be punished with either description for a term which may extend to two years and shall also be liable for fine".
- (4) Concealment of birth by secret disposal of dead body is a punishable offence under IPC.
- (5) Section 371 deals with the offence of habitual dealing in slaves.
- (6) Dishonest misappropriation of property is a punishable offence where the punishment may extend to two year or fine or both.
